Letter from our Core Founders

India's philanthropic landscape is entering a defining phase. As wealth creation accelerates, so does the recognition that private capital must play a greater role in addressing the country's complex social and environmental challenges. Increasingly, wealth creators are engaging with intent, seeking ways for their giving to create long-term, systemic impact.

Accelerate Indian Philanthropy (AIP) was founded to nurture this intent and enable purposeful action. Over the past four years, AIP has evolved into a trusted platform that informs, inspires, and facilitates strategic philanthropy. What began as a small circle of committed givers has grown into a vibrant network of over **50 founders and 300 active members**. Together, this community reflects a growing belief that thoughtful, well-directed philanthropy can be a powerful force for nation-building.

The joint AIP-BCG report, "**Wealth with Purpose,**" advanced the conversation around giving in India. Based on discussions with 100 Ultra High-Net-Worth Individuals (UHNIs), the report highlights a growing inclination among UHNIs to engage in philanthropy sooner and in a more structured manner.

As AIP enters its next chapter, the focus will be on deepening this movement to **promote and facilitate philanthropy** more widely, engaging the next generation of philanthropists, expanding the circle of givers, and fostering an enabling environment for strategic giving. We believe that India's wealth creators hold immense potential to unlock not only financial capital, but also courage, conviction, and compassion to shape a more equitable and resilient future.

Tapping Into India's Philanthropic Opportunity

While India ranks third globally in its billionaire population, with their wealth rising by over 42% in 2024¹, its philanthropic giving still lags behind global peers. Yet, the opportunity to change this story has never been greater.

At AIP, we believe that philanthropy has the power to bridge the gap between private success and public good to fuel innovation, strengthen institutions, and invest in long-term solutions that markets or governments alone cannot sustain. Philanthropy enables those with resources to take risks others cannot, to experiment, learn, and build models that can transform lives at scale.

Through our work, we aim to foster a culture of generosity and accountability among India's affluent. Our ambition is to unlock ₹10,000 crore in philanthropic capital by engaging at least 400 families in purposeful giving over the next five to seven years. We pursue this through a unique **pay-it-forward model**, offering our services pro-bono to ensure zero barriers to entry and build trust. The movement grows not through hard-sell, but through **peer inspiration**, referrals, and lived demonstration of impact.

What makes AIP different is its positioning as a **neutral and trusted enabler** — we do not charge fees, we do not champion any particular cause, and we have no nexus with the organisations that philanthropists support. Our sole focus is to empower philanthropists themselves, believing they are best placed to decide where and how their capital can transform lives.

Our measures of progress, from expanding the **founder and member network**, to purposeful engagements, and **onramping emerging givers** reflect both the ambition and the complexity of our mission. While some metrics are tangible, others challenge us to pioneer new ways of measuring influence and attribution.

With a small but highly experienced team, guided by an Advisory Board of eminent philanthropists, and funded entirely by philanthropic contributions, AIP is a movement sustained by philanthropy, for philanthropy.

Who We Are

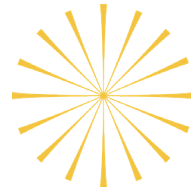

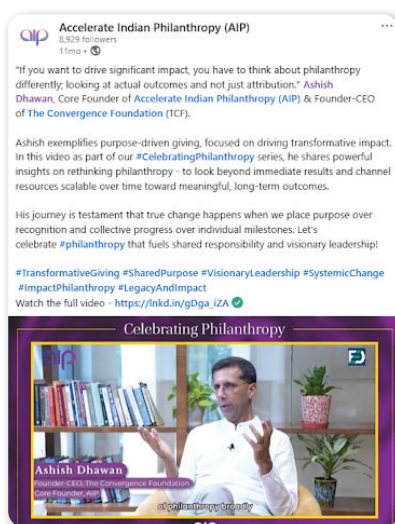
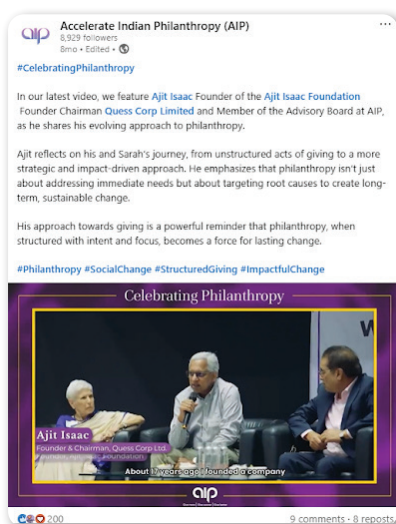
'Live to Give', authored by Rashmi Bansal

Promoting *Philanthropy*

Networking and Convenings

AIP's curated dialogues have become trusted spaces for sharing insights and experiences. From peer-hosted philanthropy evenings to closed-door thematic roundtables, our members meet peers, share learnings and explore the "why" behind their giving. The community now spans entrepreneurs, business families, investors, family offices, and nextgen givers who believe that giving is a shared journey.



In February 2025, we partnered with ILSS to curate and conduct a **focus-group discussion** between philanthropists and NPO leaders at the **India Fundraising Conference (IFRC)**.



We curated a **thematic workshop** on climate change and environment sustainability in July 2024, with participation from over **20 organisations**, including philanthropists, NPOs and subject matter experts, such as OneStepGreener, Rainmatter Foundation, Rohini Nilekani Philanthropies, Environmental Defense Fund.



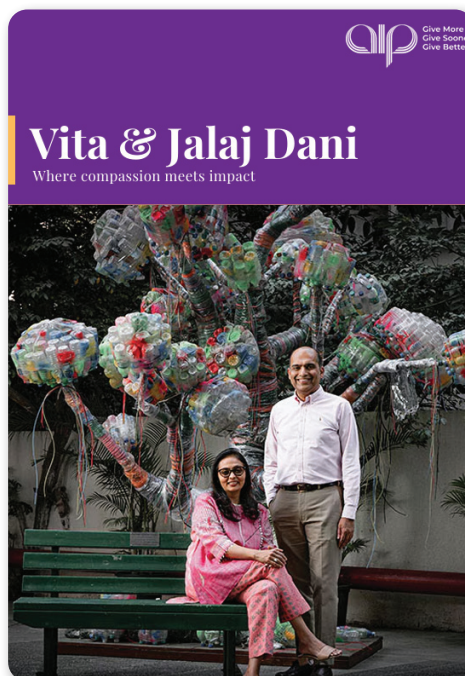
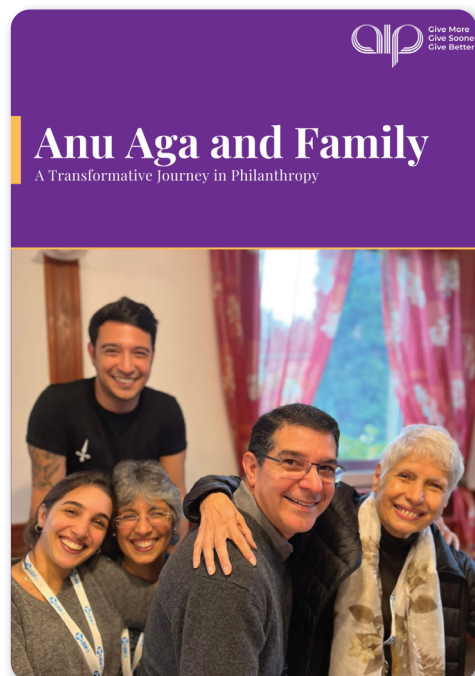

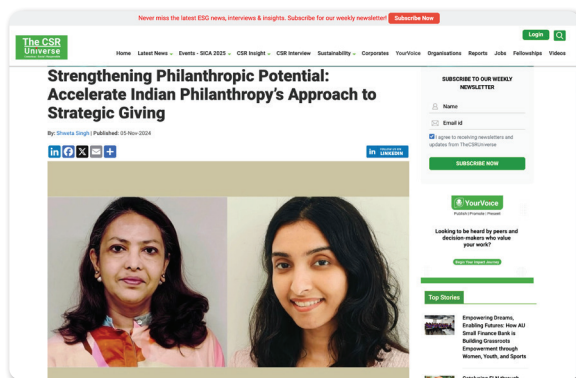

Facilitating *Philanthropy*

Launched 'Wealth with Purpose: A Report on Private Indian Philanthropy'

We conducted a joint research study with Boston Consulting Group (BCG) on Private Indian Philanthropy. The study engaged over 100 Ultra-High-Net-Worth Individuals (UHNIs), throwing up 6 distinct giver archetypes and offering a nuanced understanding of varied motivations and philanthropic approaches.

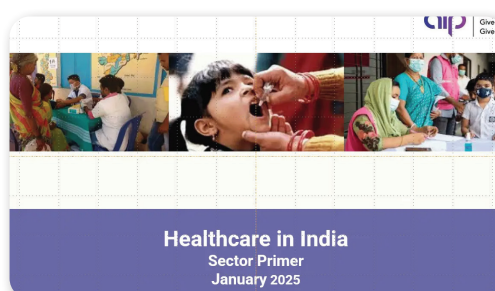
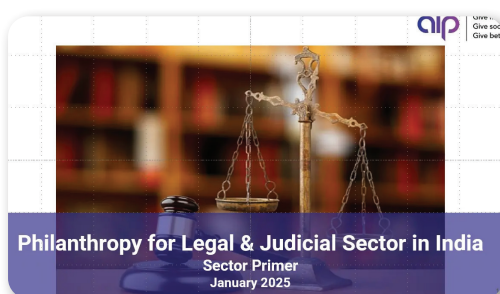
The report, launched in July 2024, also highlights the potential for them to triple annual philanthropic contributions to over ₹75,500 crore by allocating just 5 percent of their incremental wealth.

Connecting Philanthropists with Changemakers

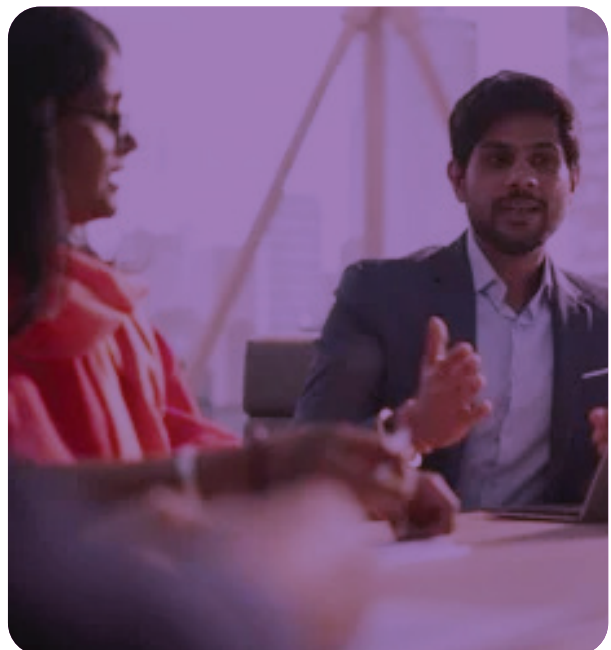
Through extensive research and collaboration with NPOs and philanthropists, we have built a repository of over 1,600 nonprofit organisations. With detailed profiling of 1,300 of them, the repository serves as a trusted resource to guide strategic partnerships between the NPOs and potential givers.

This year, we facilitated ~60 giving journeys, helping our members articulate their values, define focus areas, and translate intent into structured giving plans across

SPOTLIGHT:

Structuring a Family's Philanthropic Legacy

A leading financial services family sought guidance on aligning individual passions with a cohesive, long-term philanthropic vision. We created giving roadmaps for each member of the family customised to the causes they are passionate for. We hosted a few workshops to build their perspective on philanthropy and presented opportunities for impactful giving. Simultaneously, we are also supporting them to organise and structure their philanthropy purpose in a thoughtful institution. This partnership is helping the family transition from individual intent to a unified, enduring family philanthropic legacy.



SPOTLIGHT:

Catalysing Change: Guiding the Journey from Aspiration to Action in Skilling



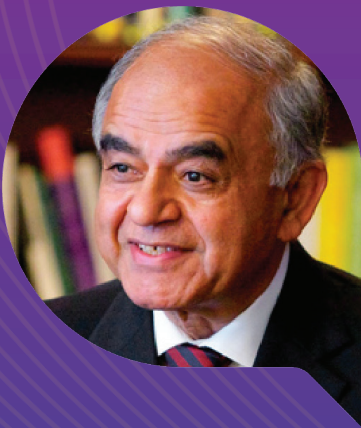
A philanthropist reached out to us with a specific ambition to set up their own skilling institute. We began by giving them a broad overview of the skilling landscape in India. They interacted with a few non-profits who are addressing the skilling gap in diverse ways, such as vocational skilling for the youth, incorporating skilling in school curricula, and future skills for young women in remote areas. This was followed by field visits to a couple of organisations. They are now in advanced discussions with a partner organization to initiate the process of a new skilling centre.

SPOTLIGHT:**From Values to Vision: Crafting a Purpose-Driven Philanthropy Roadmap**

We partnered with the second generation of a promoter family in the consumer durables sector to help them shape a focused and impactful philanthropic approach. Through deep engagements, we explored their values, connected them with sector experts, and identified causes and non-profits aligned with their purpose. By facilitating direct conversations with these organisations and developing a thoughtful fund allocation framework, we enabled the family to make informed, strategic choices. This collaboration reflects our commitment to guiding philanthropists in building meaningful and sustainable impact through a structured manner.

**SPOTLIGHT:****Strategic Alignment: Connecting Philanthropy with High-Impact Partners**

We partnered with the promoters of a leading manufacturing company to guide their philanthropy towards the cause of hearing impairment. We helped channel their giving to credible, high-impact organisations working in this space. Focusing on their philanthropic vision, we identified and vetted non-profits whose missions aligned with their purpose, ensuring a strong strategic fit. By facilitating introductions and in-depth conversations with these organisations, we empowered the family to make informed decisions about where their support would drive the most meaningful change. This engagement highlights our role in connecting philanthropists with trusted partners to amplify their impact in specialised causes.

As India's philanthropic landscape grows in ambition and complexity, AIP stands at a defining moment. So far, the team has focused on building the organisation, establishing trust, and nurturing a committed community of philanthropists. This forms our core foundation.

During this phase, the team at AIP has taken an abstract idea and built a wonderful organisation that has won the support, trust and respect of over 50 Founders, 16 pledge signatories and more than 60 families that AIP has worked with to promote their philanthropy. What gives us the most satisfaction is that we have built an organisation that has made a place for itself as a leading destination for philanthropists seeking help with their philanthropy.

For all of us at AIP, each philanthropist has been an inspiration. It has been fascinating to witness their sense of purpose, their motivations and above all, their humility. With such role models, philanthropy in India can only grow.

At AIP, we are calling this three-year journey – the journey of AIP 1.0.

We are now working on our strategy for the next phase – AIP 2.0. This will be an exciting new phase that will build tall and on the foundation of AIP 1.0. This new phase will see us focus more on “Promoting Philanthropy”, especially among emerging givers, and getting more and more wealth creators to get excited about giving more, sooner and better and to commit to their philanthropy in a very concrete manner through AIP's Accelerate India Pledge. Our experience with hundreds of wealth creators gives us immense confidence that this movement will gather pace and “giving” will become an established norm and an expectation in India and AIP will be a key catalyst and enabler.

Our path forward continues to be shaped by our call to action:

Give More, Give Sooner, Give Better.

India is creating wealth at an unprecedented pace, yet philanthropy among the ultra-wealthy is still not a norm and is still emerging as a collective expectation.

AIP 2.0 will work to change this—by showcasing new role models, building pathways for early engagement, and enabling gentle door-openers for emerging givers to get them “on-ramp” with their giving. A key pillar in this journey is the **Accelerate India Pledge**, which aims to institutionalise structured, long-term giving. Our five-year aspiration is to have **200 pledges signed, unlocking ~₹10,000 crore and more**. The AIP Pledge not only increases the quantum of giving but brings it forward in time, making purposeful philanthropy part of responsible wealth creation and leadership.

India's challenges require more than goodwill—they call for long-term investments that create impact on the ground.

AIP 2.0 will help emerging givers embrace purposeful philanthropy by deepening access to peers, subject matter experts and ecosystem partners for insights that are both cerebral and celebratory. These resources and frameworks will help philanthropists give with greater clarity and confidence, thereby inspiring, influencing and informing philanthropy.

AIP will continue to adopt a neutral and agnostic approach to philanthropy and will continue to advocate for **flexible, long-term capital**. We will support philanthropic efforts translating into meaningful, lasting change across sectors — efforts that result in impact at scale and help tackle long standing issues at their root.

From Charity to Purposeful Philanthropy

For philanthropy to truly scale, it must not only be practiced—it must be seen, valued, and celebrated.

AIP 2.0 will focus on celebrating newer role models who represent the next wave of Indian philanthropy, disseminating compelling stories and insights that make giving aspirational, and positioning philanthropy as a socially relevant marker of leadership. This will help establish philanthropy as a norm, rather than an exception.
